

Shareholders of the Company had approved the said Bonus Issue vide Ordinary Resolution passed in the Extra-ordinary General Meeting held on 15/04/2021.

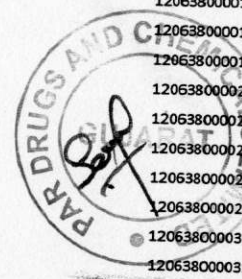
